**TVBC Clir Johnston** reported that TVBC are hopeful they will secure funds to support Rural Business. She reminded those present of the need for voter ID when voting in person at the next elections. Clir James will post a notice in the village shop.

### **Sports Field Update**

7) Cllr Elliot confirmed a further CIL bid had now been submitted to TVBC to help with funding of the proposed new building. The Clerk asked for a progress report on the outstanding ecology assessment. This had been commissioned but was delayed due to staff illness. The report will be sent to The Clerk as soon as it is available for onward transmission to TVBC to support the planning application.

The Village Hall management group and the Village shop will be asked to make a donation towards these costs as both will benefit from the generator if deployed. A further invoice for installation will follow.

# County Council welcomes additional money from Government for pothole repairs

Hampshire County Council has welcomed additional funding for pothole repairs confirmed in the Government's Spring Budget on Wednesday 15 March. The Chancellor announced a further £200m for the national Pothole Fund to help local communities to tackle this issue with £5,954,400 confirmed for Hampshire.

Over the winter period, HCC have drafted in extra resources to repair more road defects following a dramatic and sustained increase in reported issues. In total over the last three months, we have repaired 16,748 potholes and other road defects.

The Government's extra funding announcement recognises the significant challenges facing highway authorities across the country and goes some way to help us to bridge the financial gap that we face in managing 5,000 miles of road in Hampshire.

In addition to the annual funding received from the Department for Transport for highway maintenance, the County Council invests an additional £10m each year into proactive structural maintenance through our established Operation Resilience programme, designed to make roads and footways more resilient to the impacts of weather extremes and heavy use, along with an additional £7m each year for day-to-day maintenance.

Hampshire County Council is funding holiday schemes for eligible children at 132 venues over the Easter break, as part of its Holiday Activities and Food (HAF) programme

Using the funding provided by the Department for Education, the County Council – with the support of national and local organisations – has commissioned a programme of activities and healthy meals during the school holidays, primarily for children who receive income-based free school meals during term time.

The upcoming Easter itinerary follows a successful Christmas programme, which provided holiday clubs across 125 sites with 5,637 children accessing 18,500 sessions.

**Keeping up momentum - County Council finances top the agenda in ministerial meeting** The severe financial crisis facing county councils nationally in the next few years has topped the agenda of a key meeting at Hampshire County Council with Minister for Local Government, Lee Rowley MP.At the meeting held on 16 March, Hampshire Leader, Councillor Rob Humby restated the mounting pressures facing upper tier authorities across the country and highlighted the unprecedented challenges faced by Hampshire County Council in future years – with a forecast budget shortfall of £132million by April 2025.

## High praise for Hampshire's social workers following Ofsted visit

Hampshire County Council's child and family social workers are 'knowledgeable, confident and child-centred' and ensure that children have a 'meaningful voice' in decisions about their care. This is one of many positive findings highlighted by Ofsted, following a focused visit to Hampshire Children's Services.Local Authorities are required to undergo Ofsted inspections every three years, with a focused visit or Joint Targeted Area Inspection in the intervening two years. A visit was most recently undertaken to Hampshire Children's Services on 31 January and 1 February 2023, focusing specifically on children in care.
